Every year since 2006, GPRO Valparaiso Palace Hotel & Spa has obtained the converted ISO 14001 certification of environmental quality management. Furthermore, we have also received the distinction of "Eco-Resort" and "Umwelt Champion (Environmental Champion)" awarded by the tour operator TUI.

One of our fundamental principles is too efficiently and effectively management our environmental with these values.

## ***What does GPRO Valparaiso Palace do to protect the environment?***

1. We manage our pollution and waste
  - We classify and separate the garbage for recycling
  - We control our atmospheric emissions
  - We monitor the noise we produce
  - We delivered hazardous waste to authorized managers
  
2. We save water
  - We install flow restrictors on faucets and shower
  - We change the towels according to customer ecological criteria
  - We watering during the peak insolation hours
  - In our gardens, native plants dominate
  
3. We save energy
  - We take advantage of natural light
  - We use automatic sensor switches
  - We use energy efficient light bulbs
  - We control the temperature by thermostats
  - We have a place to recharge electric vehicles.
